## 1. Introduction

Our website, <https://impsci.tracs.unc.edu> (hereinafter: "the website") uses cookies and other related technologies (for convenience all technologies are referred to as "cookies"). ## 2. Cookies

When you visit our website it can be necessary to store and/or read certain data from your device by using technologies such as cookies.

### 2.1 Technical or functional cookies

Some cookies ensure that certain parts of the website work properly and that your user preferences remain known. By placing functional cookies, we make it easier for you to visit our website. This way, you do not need to repeatedly enter the same information when visiting our website and, for example, the items remain in your shopping cart until you have paid. We may place these cookies without your consent.

### 2.2 Statistics cookies

### 2.3 Marketing/Tracking cookies
